#### CONTRACT TERMS:

**BOOKINGS:** To secure a date, a \$150.00 deposit is required to be paid. The deposit amount is stated in the quote supplied by the Artist. Amounts for services which are required to be paid in full at the time of service are specified on the written quotation provided. The deposit is non-refundable and non-transferable after three (3) days have elapsed from the date of payment receipt. Please be advised, dates and scheduled client times will only be reserved once a deposit is received.

**PAYMENT:** Payments can be made by cash, check, and all major credit cards. A \$150.00 nonrefundable deposit of bridal services is due at time of booking. This secures your wedding date, the time to allow for makeup services for your wedding party, and also covers your bridal trial. The final balance of bridal services is due two weeks before your wedding. If your wedding is less than two weeks away at time of booking, 100% of payment is due.

**TRAVEL FEE:** Travel and toll fees may be incurred depending on the return distance of travel required. This amount specified in the quotation and is determined according to the location provided at the time of enquiry. If the location of the service changes after the agreed upon quotation is given and/or deposit is paid, the Artist reserves the right to adjust the travel fee if the distance is increased.

**PARKING FEES:** Where parking or valet fees or may be incurred, the amount will be included in the final bill and due for payment on the day of the event.

**CANCELLATION:** Your booking is a reserved spot. If you decide to cancel your wedding day services, you will not receive a refund of your deposit. If you cancel with less than two weeks before your wedding, you will not receive back the deposit or final payment. All cancellations must be submitted in written form by email.

**SERVICE LOCATION & REQUIREMENTS:** The location of makeup services for the day-of-event will be at the Bride's discretion, but there are certain requirements the artist will need to complete the services. A set-up table/work area/chair/trashcan/outlet if using airbrush will need to be made available for the Makeup Artist. Ample lighting, whether by means of natural light or by lamps, is necessary for services to be performed properly. Artist will arrive 15 minutes prior to set-up. Please communicate the hotel room number if applicable by email or text.

**DELAYS:** Please be prepared to start when we arrive. All ladies receiving makeup should have a clean face & be ready to start. This is very important so we can stay on schedule, and we can finish applications in the allotted time. The list of girls receiving services is due two weeks before your wedding. Please include full name & all services needed.

**SOCIAL MEDIA & WEBSITE:** Photos taken at the trial or your professional photos may be used as examples of my work for future clients to view. Your photographer will receive proper credit for their work. You agree to me using these

photos, as well as give consent to using your professional photos on my website/portfolio/social media. We will email you to request these photos and will also reach out to your photographer.

**LIABILITY:** All brushes and makeup products are kept sanitary and are sanitized between every makeup application. Makeup products used are hypoallergenic. Any skin condition should be reported by the client to the makeup artist prior to application and, if need be, a sample test of makeup may be performed on the skin to test reaction.

**GENERAL PROVISIONS:**

- (a) In the event the Client fails to pay any periodic or instalment payments due, the Artist may cease work without breach pending payment or resolution of dispute.
- (b) The Beauty Collective LLC shall not be liable for any delay or non-performance due to circumstances beyond the Artist's control.
- (c) The Beauty Collective LLC and all employees are an independent contractor and not an employee of Client.
- (d) Any changes to this document must be agreed upon in writing by both the Artist and the Client prior to payment of the deposit by the Client.
- (e) This Agreement constitutes the entire agreement between the Client and The Beauty Collective LLC, and supersedes any prior understanding or representation of any kind preceding the date of this Agreement. There are no other promises, conditions, understandings or other agreements, whether oral or written, relating to the subject matter of this Agreement. By paying the deposit, the Client agrees that they have read and understand all the terms and conditions outlined above. The Client also understands that the Client will be financially responsible for self, along with bridal party and all deposit(s) made are non-refundable.
